The process was conducted over a six-month period and identified three major and two secondary needs in Florence County.

This helped us shape exciting new goals for our United Way.

Achieving these goals will require a new way to invest our resources, focus our funding, and build collective impact. This is a new direction for our community fueled by the voices that matter, **YOURS**. If we want to lead Florence County to a brighter future together, we must embrace that we are in the **IMPACT** business and the **DONOR** is our customer.

# **COLLECTIVE IMPACT**

We must all work together to ensure every member of our community reaches their full potential. We could all work independently and then compare our results, but that is not the most efficient and effective strategy. Instead, we plan to put this Community Game Plan into action through collective impact.

Collective impact is the commitment of a group of individuals from different sectors to a common agenda for solving a specific social problem, using a structured form of collaboration. Successful collective impact initiatives have five conditions that together produce true alignment and lead to powerful results: a common agenda, shared measurement systems, mutually reinforcing activities, continuous communication, and a backbone support organization (Stanford Social Innovation Review).

# **HOW WE WILL TRACK RESULTS**

Results-Based Accountability (RBA) is a planning and evaluation framework developed by Mark Friedman. Over the past 15 years, many nonprofits and state agencies have found RBA a powerful, effective tool. UWFC will be implementing the RBA outcome measurement framework.

RBA has been used to improve population health and wellbeing and program performance across the nation and beyond. RBA allows policymakers, funders, and program managers to assess how well they are performing in attaining an outcome and where changes are needed to help achieve the desired result.



RBA helps communities and organizations move from talking about problems to taking action to solve them through a data-driven decision-making process. It's a straightforward, common-sense foundation that everyone can grasp.

With the results-based approach, RBA strengthens the nonprofit sector's capacity to make significant, sustained improvements for the well-being of Florence County's communities and individuals.



Florence County has a higher percentage of children who are not in a twoparent family home and are raised by either a single parent or other family members (over 51%) compared to the percentage in South Carolina (42.6%). SC Profile Early Education

Nearly 80% of households that are single-female-headed with children fall below the ALICE threshold (of which 45% are in poverty).

When a single parent is struggling to make ends meet, it becomes increasingly difficult for the child's developmental needs to be met.

# **Our Community Goal**

Increase the number of children who meet developmental milestones and enter kindergarten ready

2023 Baseline: 28% of children in School Districts 2, 3, and 5 entered kindergarten demonstrating readiness. (SC Report Cards)

# Program- Level Goal

To support and improve access to resources focusing on the physical, social, emotional, cognitive, and language development of children from birth through age 4, while also increasing participation from families and caregivers in their child's learning.

# **Objectives**

#### **Objective** #1

Children start kindergarten developmentally on track.

#### **Objective #2**

Parents, caregivers, and/or guardians can access services that support the family and the academic success of their children.

#### **Objective** #3

Working families have access to affordable childcare and can pursue positive enrichment opportunities for themselves and their children.

# Our Vision

A community where the developmental needs of all children are met to ensure they reach their full potential as they enter kindergarten.

# Strategies to achieve our vision

#### Fund

- Programs that improve academic and developmental milestones for children from birth through age 4.
- Programs that increase the involvement of families, caregivers, and the community in the success of children from birth through age 4.
- Programs that improve access to equitable learning opportunities and childcare for children.

#### **Advocate**

• Support local, state, and national efforts to increase availability and access to quality early childhood and pre-school programs.

### Collaborate

• Collaborate with local, and state stakeholders to promote and support resources and institutions that focus on the development of the whole child and support the family.

#### Educate

- Promote parent engagement and leadership in early education for children from birth through age 4.
- Share key child development concepts such as brain development, social development, motor skills, etc.

#### Advocate

• Support community efforts to improve access to equitable learning opportunities and activities for children and youth, particularly during the summer and in rural areas.

### Collaborate

• Collaborate with various communities and agencies to exchange ideas, leverage resources, and drive collective action to better meet the needs of children and youth.







2023 Baseline: 8 homes were repaired in Florence County in the year of 2023. (As reported by home repair organizations)

# Program- Level Goal

To support and improve access to home rehabilitation services for those who do not have the physical or financial means to maintain their homes.

# **Objectives**

#### **Objective** #1

Homeowners of eligible homes receive comprehensive repairs in a timely manner.

#### **Objective** #2

Homeowners of ineligible homes receive support to obtain sustainable housing.

# Fund

- Programs that provide home repairs to homeowners in Florence County.
- Opportunities that restore hope and stability to clients as they navigate unsafe living conditions.

#### Advocate

- Advocate for local efforts to increase the availability of and access to affordable housing.
- Advocate for volunteers, contractors, suppliers, and other needed resources to maximize the number of individuals served.

# Collaborate

- Collaborate with local contractors, suppliers, and government to ensure programs are efficient and effective.
- Seek opportunities for unified effort to be replicated across the community and not duplicated.

# Educate

- Educate the community about the value and importance of home maintenance, budgeting, home insurance, weatherization, and efficiency measures.
- Educate the community about available programming and services to support home rehabilitation.

# **Our Community Goal**

Provide support for rent and utilities and access to emergency shelter/sustainable housing

# **Program- Level Goal**

Enhance the support system for Florence County residents, ensuring access to financial assistance for rent, utilities, and emergency shelters coupled with life-skills training.

# **Objectives**

#### **Objective** #1

People have access to emergency housing services (i.e. rent and utility assistance, emergency shelter, etc.).

#### **Objective** #2

People have access to opportunities to learn important life skills (i.e. financial literacy, resume building, budgeting, career counseling, etc.).

In Florence County, ALICE households increased 80% from 2010-2022. United for ALICE

# Our Vision

A future where everyone has access to shelterrelated emergency services and opportunities to learn the necessary skills to impact their economic mobility.

# Strategies to achieve our vision

### Fund

- Programs that provide emergency assistance for rent, utilities, and shelter.
- Opportunities that restore hope and stability to clients as they move from emergency needs to self-sufficiency.

#### **Advocate**

- Advocate for shelter options for nontraditional circumstances.
- Advocate for policies and programs that assist those struggling with basic needs.

### Collaborate

- Support local task forces and initiatives ensuring no one is unsheltered.
- Collaborate with basic needs providers, employment services, and other stakeholders to provide more long-term solutions for those struggling to make ends meet.

#### Educate

• Educate the community on available resources for basic needs and opportunities to improve their circumstances. Educate the community on ALICE and the importance of basic needs assistance in Florence County.
